## NCTF-RH Releases Comprehensive Status Update of Environmental Activities

Navy Closure Task Force-Red Hill has made significant progress in its deliberate environmental work in and around the Red Hill Bulk Fuel Storage Facility.

This document summarizes the environmental actions taken to date, including environmental monitoring and testing, environmental remediation actions, coordination efforts with regulators, and public communication.



## Well Reactivation Update: Navy Aiea-Halawa Shaft

NCTF-RH is conducting preliminary testing as part of a pilot study of its granular activated carbon (GAC) filtration system at the Navy-Aiea Halawa Shaft (NAHS) to demonstrate the system works properly prior to reactivation. In February, the Hawaii Department of Health granted the Navy conditional approval to reactivate the well upon meeting specific requirements, including successful completion of the study.

The study involves testing the NAHS water before and after it is run through the GAC treatment system. Sample results from the study will be shared with the public when complete on the new **Well Recovery and Water Resiliency** page on the Joint Base Pearl Harbor-Hickam [Safe Waters](#) website.

NCTF-RH encourages the public to attend a webinar on April 29, at 5 p.m. dedicated to the reactivation of the NAHS. This webinar will build on the information provided at the March Open House and the Fuel Tank Advisory Committee Meeting on April 9.

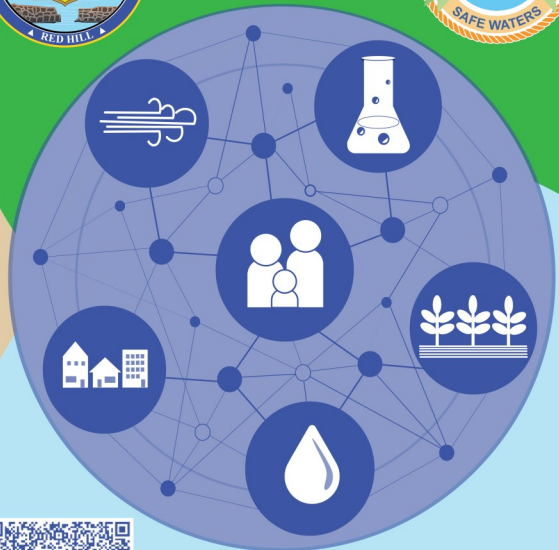
