The mission of Navy Closure Task Force-Red Hill (NCTF-RH) is to execute the permanent decommissioning of the Red Hill Bulk Fuel Storage Facility (RHBFSF) safely and expeditiously, and continue long-term environmental remediation in coordination with State and Federal regulators in order to protect public health and the environment.

FACT CHECK: Regulators have access to unvalidated drinking water and groundwater test results, before the final, validated results are shared with the public.

Ongoing Site Assessment Determines Long-Term Environmental Actions

Navy Closure Task Force-Red Hill is conducting a site assessment to address prior fuel releases at the Red Hill Bulk Fuel Storage Facility.

During the site assessment, the team will gather information to understand and determine the presence or absence of fuel in the environment. Afterward, a field investigation will determine the nature and extent of the residual fuel, to develop a complete understanding of the cleanup that needs to be performed.

These activities are part of an overall environmental management program, which will determine the best course of action for future environmental clean-up and long-term monitoring.

Throughout this effort, the Navy will submit all work plans to the Environmental Protection Agency and Hawaii Department of Health for review and approval prior to the start of any work.

Redesigned NCTF-RH Dashboard Includes Pipeline Removal Progress

Navy Closure Task Force-Red Hill launched its new Operations Dashboard on the website and mobile app.

The revamped design provides clearer reporting of Tank Cleaning operations and status, and the amounts of residual fuel and sludge removed.

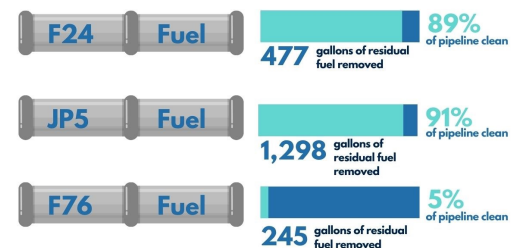
Users will now also be able to track NCTF-RH's progress of pipeline cleaning and removal operations, with data that shows how much residual fuel was captured.

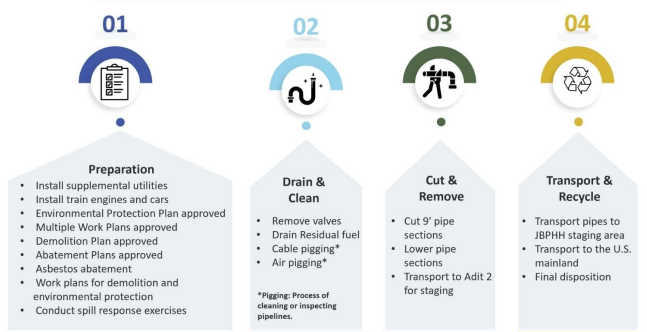


Navy Closure Task Force-Red Hill Operations Dashboard
